**Camp Director • Scott Kneifl**  
**Wayne State Head Volleyball Coach**

Scott Kneifl has elevated the Wildcat program to a new level in his four seasons as head coach, directing Wayne State College to a 102-40 overall record and a 50-20 mark in the Northern Sun Conference. The Wildcats have qualified for the NCAA National Tournament the last four seasons and added the school's first-ever NSIC Tournament title in 2007. Kneifl, the 2005 NSIC Co-Coach of the Year, coached the Wildcats to a 23-10 record in 2008, ending the year ranked 25th in the final Bison/AVCA Division II Coaches Top 25 Poll.



**WSC Assistant Volleyball Coach Kim Edwards**

Kim Edwards enters her second season as an assistant coach with the Wayne State College volleyball program. The Sioux City (Iowa) Heelan High School graduate coaches the setters for the Wildcats while also handling recruiting duties and camp coordinator responsibilities. Before coming to WSC, Edwards served two seasons as a graduate assistant coach at Emporia State in Kansas where she was a standout setter. She was a First Team All-MIAA selection as a senior, recording a league-best 1,489 assists.

**Christina Houghtelling**

Christina Houghtelling begins her second season as a graduate assistant coach with the Wildcats. The Cambridge native was a two-time AVCA All-American and two-time All Big 12 performer for Nebraska and was named the 2005 AVCA National Player of the Year. She was the Big 12 Conference Defensive Player of the Year in 2007 as a senior.
